**Bucks County near miss – #1 Wrightstown -** we had a call in an older home that only had battery operated smoke detectors on every level. There was a newer babysitter at the home watching 6 kids. Some kids were from different families. One child went to bed in an upstairs bedroom but left the door open because she wasn't used to the house and wanted to hear the parents come home. The babysitter thought she smelled smoke at some point after the child went to bed, check a few places and

thought everything was ok. A short time later the smoke detector goes off in the upstairs hallway. There was an active electrical fire behind the canopy bed where the girl was sleeping. The babysitter woke the girl up and got everybody out of the house safety.

If the hallway door was closed along with no smoke detector in the bedroom, I believe this fire would have had a completely different outcome. Ted Middleton, Fire Marshal

#2 Bristol Twp. - a fire in a 1 story, 3 bedrooms SFD had NO smoke detectors present! This was an unregistered rental property, fire began behind the oil-fired boiler due to an improperly installed flue pipe. Fortunately the one resident was home during the day and saw the smoke and flames. Kevin Dippolito, Fire Marshal

Sprinkler Saves
Warrington – A fire in mulch
on the exterior burned
through the siding
immediately above the

foundation of a townhouse and into the basement where two sprinkler heads activated. Firefighters extinguished a small fire on the exterior. Had it not been for the sprinklers, the glued wooden I-beam (TJI) would have burned immediately inside the front door and presented a collapse scenario for firefighters.

**D**oylestown Borough – A fire occurred at CB West High school in a welding booth. Fire was extinguished by sprinkler system.

**D**uring February a cylinder being filled in Bucks County exploded. All pieces were contained within the fill station and no one was hurt. It was a low pressure cylinder. Several key points have been raised: 1. why didn't the "burse disk" operate? It was found intact. Did the failure occur at a lesser pressure than the burst disk (3250 PSI) or did the disk fail to operate? 2. Does everyone who is filling air and oxygen cylinders fill them in an approved containment chamber? The violence of this explosion damaged the containment chamber and would have caused serious injury or death.

In response to the article that appeared in the NFPA Journal -Editor NFPA Journal Ouincy, MA 02169 An article in the most recent NFPA Journal discussed the "two-tiered approach to firefighter qualifications." The issue before the NFPA 1001 Firefighter Qualifications Committee is the potential certification of firefighters who do not meet the current standards, but could be used in an outside or support role. I have heard this argument on numerous occasions and I am continually confused by this issue. The article portends that somehow firefighters who want to serve in a support role are not allowed to do so because of the NFPA Standard. My confusion is that the NFPA 1001 standard

is a voluntary standard and is only mandatory if the authority having jurisdiction decides to make it mandatory at the local level. No firefighter regardless of qualifications is barred from the scene of an emergency unless the local fire department makes that decision. So, if a fire department chooses to use firefighters who do not meet the national standard for whatever reason, they have the right to do so and I fully agree with that. The question is not what a local fire department may need to do to staff their operations, the question is what should the "national firefighter qualification standard" be. What is being requested is that the national standard change so under qualified personnel may then be nationally certified to the NFPA Professional Oualifications Standards. In my opinion this is a decision to be carefully considered as decades of work has created > a very successful firefighter national standard that is the envy of many other occupations. To nationally certify firefighters to a less stringent standard has no justification in my opinion and is a path down a very slippery slope that I do not think we want to descend to. An attempt to try to twist the "national standard" to meet

the needs of a few fire departments, so that they can say their personnel are nationally certified is an abrogation of the professional qualification standards, that the several hundred thousands of currently nationally certified firefighters should not stand for. I could go into the operational and regionalization issues that the two tier standard would create, but suffice it to say they are numerous.

The issue before the NFPA 1001 Committee is what should the national standard be, not what is convenient for a few local jurisdictions. Let me state one more time, the jurisdictions who want to used "outside" or "support" firefighting personnel on emergencies can do so and in fact do so everyday currently. Many frame this as a volunteer issue and I disagree as in my opinion in many areas the training necessary to be certified is non-existent or not available in the format it should be in to properly train volunteer firefighters. My state of Maryland has thousands of nationally certified volunteer firefighters and officers to prove this. Perhaps this is really a training issue and not a firefighter certification issue. Let's work together to build the firefighter
