May 21--An explosion during an auto parts plant fire that ultimately stopped production of the Ford F-150 was so violent that it threw a worker through the air into a door jamb. Vehicles in the parking lot caught fire and were damaged by flying debris. A fire "detector did not alert occupants."

The explosion and a subsequent blast early on the morning of May 2 at the Meridian Magnesium factory in Eaton Rapids occurred because the fire suppression system at the plant added water to molten magnesium. Experts said that is like arming a bomb.

### PA Child Labor Laws Up-date -

The following is the Bureaus interpretation of Section 7 (6) ii of the Child Labor Act (CLA) relating to Minors

serving in volunteer emergency service organizations. For your reference, the applicable section is copied below.

- (a) General rule. --An individual who is 14 years of age or older who is a member of a volunteer emergency service organization may participate in training and emergency service activities except as follows:
- (1) A minor may not operate a truck, ambulance or other official fire vehicle.
- (2) A minor may not operate an aerial ladder, aerial platform or hydraulic jack.
- (3) A minor may not use rubber electrical gloves, insulated wire gloves, insulated wire cutters, life nets or acetylene cutting units.
- (4) A minor may not operate the pump of a fire vehicle while at the scene of a fire.
- (5) A minor may not enter a burning structure under any circumstance including a training exercise.
- (6) A minor may not engage in firefighting activities unless all of the following apply:
- (i) The minor is 16 years of age or older.
- (ii) The minor has successfully completed a course of training equal to

the standards for basic firefighting established by the State Fire Commissioner and the Department of Conservation and Natural Resources.

(iii) The minor is under the direct supervision and control of the fire chief, an experienced line officer or a designated forest fire warden.

Language contained within the CLA implies that a minors' participation in any firefighting activity is conditional under (6) i. ii. iii.

More specifically under item (6) ii, the CLA requires completion of courses in both Basic Firefighting established by the State Fire Commission and Basic Firefighting established by DCNR before a minor can participate in any emergency activities.

Accordingly, a minor could not perform exterior duties at a structure fire without the basic firefighting training approved by DCNR.

The answer to your second question is tied in to the answer of the first question. A minor without the required training would be prohibited from participating in any firefighting activities which

would include all activities surrounding the scene of a fire emergency.

Update - Fluorine Free Foam (F3)

New York State now has introduced a Senate bill banning PFOS, PFOA and four PFAS compounds in AFFF firefighting foam and turnout gear. As of 2020, the state of Washington will no longer allow Fire Department to use or train with AFFF. fluorinated firefighting agents. In fact, some European entities and two Australian states have banned PFAS (AFFF) firefighting agents as well. If your State or county follows these trends, National Foam is already there with an effective fluorine free (F3) replacement.

Fire sprinklers might not be required in all of Hawaii's residences, but certain residents have started demanding them.

Following a fire last year at the Marco Polo complex that killed four people and caused more than \$100 million in damage, condo owners voted in favor of installing fire sprinklers there, reports the Associated Press.

Don Jolley, fire chief and the first vice president of the Fire Chiefs' Association of British Columbia stated that fire sprinkler naysayers have been inadvertently promoting the need for home fire sprinklers. "Overtly they are stating to elected officials and the public that speed is

everything," he states.
"Subliminally, though, they are validating for fire sprinklers in a strong manner. There will never be a quicker response than a fire sprinkler head activating in response to a fire in the incipient, or other early stages.

**F**ive children lost their lives during a Greensboro, North Carolina, residential fire this month. News reports state that the two boys and three girls, ranging in age from 18 months to nine years old, were refugees from the Democratic Republic of Congo. The fire started in the kitchen, and the home did not have working smoke alarms, according to a CBS affiliate that obtained this information from the North Carolina Department of Insurance.

"People tell me all the time that, 'I know my way out. I know my house,""
Greensboro Fire Department Timothy Henshaw told a local Fox station. "Even in a house that you live in and when that smoke is on the floor, the toxic gases are so hot. They become superheated. You become unaware of what's going on."

According to NFPA, you may have as little as one to two minutes from the time a smoke alarm sounds to safely escape a fire. Per NFPA's research, three of every five home fire deaths resulted from fires in homes with no smoke alarms or no working smoke alarms.

In a separate fire incident this month in Asheville, North Carolina, NFPA has received a report that a kitchen fire was controlled by a single fire sprinkler. A family was displaced, but the activation resulted in no injuries or deaths.

NFPA research confirms the live-saving abilities of working smoke alarms and home fire sprinklers; according to NFPA's most recent "U.S. Experience with Sprinklers" report, the home fire death rate was 90 percent lower when fire sprinklers and hardwired smoke alarms were present.

A smoke alarm's age can be determined by looking on the back or side of the smoke alarm, where the date of manufacture can be found. Smoke alarms should be replaced 10 years from that date (not the date of purchase or installation).

A new all wood 80-story building is being proposed in Chicago. Many other wooden buildings are planned, but an 18-story dormitory recently opened at the University of British Columbia.

FEMA is streamlining its mission to focus on coordination with state and local stakeholders before disasters even strike in order to shorten disaster recovery times.

Why the changes? 2017 was particularly full of disasters -- there were 16 events that exceeded \$1 billion in total damage. An estimated \$306 billion in losses made 2017 the most expensive year ever for natural disasters. Three hurricanes in succession in August and September combined with the Western wildfires greatly stressed FEMA's capacity to support these response and recovery operations.
